The property to be owned and controlled by the stock company. The college to be nonsectarian, eminently classical, normal and practical containing the following departments.

I Classical, II Philosophical, III Scientific, IV Normal, V Preparatory,  
VI Elocutionary, VII Commercial, VIII Engineering, IX Musical,  
X Art.

The President of the institution securing the faculty and paying all costs incurred in conducting the college.
